ANOTHER SUCCESS OF OUR PROGRAM WAS THE SUCCESSFUL BIRTH OF SEVERAL BABIES AND PARENTS CHOOSING TO BREAST-FEED. WE HAVE ALSO SEEN MORE INVOLVEMENT WITH FATHERS AT GROUP CONNECTIONS AND VISITS.
